About Me

I am a 42-year resident of Newport Beach, Caltech-educated with a PhD in physics. For the first 29 of those years I was, as I believe every resident should have a right to be, blissfully uninvolved in the details of City government, assuming it was being well looked over by residents wishing to be more involved than I.

That illusion was shattered in early 2009 when I was personally affected by a City staff approval made without the slightest public outreach, and without even a path for appeal to my fellow citizens on the City Council who I assumed had been overseeing them.

Since then, I have closely watched every City Council meeting, and since 2011, personally attended all but one or two, as well as most other City-hosted public meetings. I have heard the have relentlessly questioned why my City is doing much of what it is doing

residents' concerns, and I have relentlessly questioned why my City is doing much of what it is doing.

Many watching the Council and Planning Commission broadcasts will have seen me commenting. Fewer may be aware of my far more extensive written comments, which can be found in the meeting archives. I am the only candidate with anything approaching that record.

Why I Am Running

I am running because I believe that for a Council-Manager government to work for the benefit of the public that created it, the 80,000+ residents of Newport Beach who I would be trying to represent need people on their Council asking the kinds of questions of the professional staff that I have been asking since 2009.

Without such vigilance, we get things like Measure EE on the 2012 ballot, in which a Council and staff caught not following the path the people had set for them in the City Charter, placed before voters a single yes-no vote on 38 changes to that Charter, deceptively described as a vote to ban red light traffic cameras. Those not wanting red light cameras unwittingly approved 37 unrelated changes – several of which had been rejected when presented for individual votes on earlier ballots. Rather than obeying the original Charter, those changes allowed the Council and staff to continue doing what they had.

More recently, staff, not the Council, created a shadowy three Council member "Solid Waste Working Group" to hammer out a new residential trash collection contract, apparently oblivious to the citizen-enacted ordinance which the Council should have been bound to follow. Contrary to what the Council rubberstamped, that ordinance required the full cost of curbside residential trash collection *and* disposal to be paid – like street sweeping – out of our basic residential property tax.

Still more recently, staff, with the witting or unwitting complicity of the Council, has continued a pattern of bending rules to the point of unrecognizability to approve land use changes without the citizen-required Greenlight votes. The most recent case in point was allowing the Planning Commission to approve a 22-story, 159-unit luxury residential tower on the Newport Center Marriott property – land the citizens had unequivocally designated for use as a visitor-serving 611-room hotel. This included a \$100,000 per room monetary exaction from the developer that seems to have been privately agreed to by the Council. My effort to appeal this for public review before them was, in an unprecedented move, rejected by staff. Had I been on the Council, I believe the result would have been different.

And without follow-through, the Council's rare efforts, at citizen request, to take policy-making into its own hands (where it should always lie) have failed, as in its 2019 attempt to institute lobbyist registration. Three years later, we have exactly one registered lobbyist, and even for her, the public doesn't know what she has been hired to lobby about.

But Council oversight alone is not effective unless there are welcoming avenues for public input. And, sadly, I have seen Council meetings become less welcoming, not more, in the 13 years I've been watching.

As an example of the positive changes I would like to see, here are some possible reforms to make City Council meetings more welcoming again:

- Reemphasize the Mayor's purely ceremonial role by establishing a policy of annual rotation of the Mayor and Mayor
 Pro Tem positions based not on politics but on right of refusal by the longest-serving members who have not
 previously filled the positions.
- Restore the ability of any Council member to place an item on the agenda for discussion.

- Restore the regular business meetings to a reasonable and predictable evening hour, such as 7:00 p.m. And hold them twice per month, every month, as originally envisioned.
- Reserve study sessions for study, with no decisions or direction from Council given at them.
- Hold study sessions not on the same day as the regular meetings, but on alternate Tuesdays, and also at a reasonable evening hour.
- Have the Clerk read the titles of the Consent Calendar items.
- Restore the ability of the public to pull items from the Consent Calendar for separate discussion and vote.
- Restore the former 5-minute limit for public comments, or at least 4 minutes.
- Stream all public meetings and allow those who can't attend in person to participate by Zoom (or some equivalent).

And to ensure we elect the people who can best serve as our citizen watchdogs over the professional staff, I think we also need to reform our election system:

- We need to either switch to "by district" elections in which the people of a district, and only they, get to select the person who claims to represent them. Or we need to eliminate the districts entirely, so every Council member understands they represent every citizen equally.
- To encourage better people to enter the races, we also need to abandon our single-ballot, winner-take-all voting system and adopt one in which many candidates can run with confidence the best will emerge through a system of primaries and run-offs, or one of their electronic equivalents, such as "ranked choice" voting.

Challenging issues that are not easy to solve continue to be homelessness and the proliferation of residential care facilities i.e., sober living homes. Both Federal and State laws severely handicap our City when it comes to both these controversial issues. However, having been involved directly with both items for many years, I am convinced progress can be made as we head into the future. Money cannot simply be thrown at the problem for it to go away. We must find creative strategies, partner with neighboring cities and work collaboratively with our elected State and Federal representatives to find solutions.

Fortunately, most of Newport Beach's splendor does not require much change. We are blessed with a beautiful coastline, a gorgeous harbor and protected wildlife preserves. We have a vibrant commercial and tourist industry that helps fund many of our exceptional city sponsored services. Senior, adult, and youth activities abound. Parents can utilize afterschool programing at a reasonable cost so they can continue working even when school finishes for the day. Our Junior Lifeguard program is one of the most sought-after summer activities. Oasis is respected nationally as one of the best Senior Centers around. Just this year, our City will complete building our first Animal Shelter, dedicated specifically for Newport Beach. Lastly, we have some of the most talented and hardworking City staff who serve you, the taxpayers with respect. It is my goal we continue to provide the very best, while improving all the community services available to you.

As a founding Board member of the Newport Beach Foundation, I started a Parent Education Series to help parents navigate through the difficult issues facing families today. I am also proud to have supported our organization's overwhelmingly successful efforts to ignite the next generation of leadership in the City, through our Distinguished Citizen and high school scholarship programs.

Public safety is my top priority. I have the utmost esteem for our police and fire departments and have worked closely with them in partnerships of community engagement and education. As the Vice President of the Cameo Community Homeowner's Association, and with the backing of Council and the Police Department, I successfully implemented proactive security measures that previous boards told residents could not be accomplished.

I support fully funding our top-notch Police Department and helping relieve them of the burden of performing social work in response to our homeless population, to allow them to focus on what they do best, defending our City and protecting our neighborhoods.

Despite our current Councilmembers spending millions of taxpayer dollars, the number of people experiencing homelessness in Newport Beach has increased by 50%, while our neighboring cities, Costa Mesa and Laguna Beach, saw 20% and 60% reductions, respectively. This is a failure that warrants a change in our leadership.

We also need Council representatives who will fight to combat the 80 new housing laws that the State has enacted in the last seven years; the 4,800+ RHNA and affordable housing-unit requirement, ADU laws that cannot be circumvented by HOA restrictions, lot splitting, density bonuses, and supportive care homes.

As a land use attorney and two-term Planning Commissioner, I am best qualified to help the City push back against Sacramento's housing mandates, identify defensive strategies to mitigate the impacts to our City's charm and character, and stand behind our Greenlight Initiative.

There's no substitute for listening and community collaboration, but leadership requires action, solutions and the relationships to execute.
